External Advisory Board Members for the WELLBASED project







WELLBASED (IMPROVING HEALTH, WELLBEING AND EQUALITY BY EVIDENCED-BASED URBAN POLICIES FOR TACKLING ENERGY POVERTY) is a European project funded under the HORIZON 2020 programme of the European Commission.

The project's objectives are to design, implement and evaluate a comprehensive urban programme to significantly reduce energy poverty and its effects on the citizens health and wellbeing, built on evidence-based approaches in six pilot cities that represent not only different urban realities but also a diverse range of welfare and healthcare models.

Energy poverty is becoming a main challenge of the European welfare systems and beyond, abounding on the inequalities derived from living conditions and social determinants, with a direct and negative impact on health and wellbeing, mainly in urban contexts. Health problems attributable to energy poverty include respiratory diseases, heart attacks, stroke and mental disorders (stress, anxiety, depression), but also acute health issues, such as hypothermia, injuries or influenza. The complex nature of this recently identified phenomenon requires a comprehensive analysis of the problem and its solution from a multidimensional approach, which should involve environmental, political, social, regulatory and psychological issues, thus involving other Social Determinants of Health and health inequalities. Urban policies and initiatives might respond very efficiently to energy poverty and their effects on the citizens wellbeing and health, by providing evidence-based interventions covering different angles of the challenges, including complementary actions covering individual (behavioural) but also social-political actions (regulations, urban planning) that include health in all policies. Based on the socioecological model, WELLBASED will design, implement and evaluate a comprehensive urban programme to reduce energy poverty and their effects on the citizens health and wellbeing in 6 different pilot cities in Europe: Valencia-Spain, Heerlen -Netherlands, Leeds-UK, Edirne-Turkey, Obuda -Hungary and Jelgava- Latvia. The project's multidisciplinary consortium is made up of 19 partners from 10 countries. It started in March 2021 and will last 4 years.

As a WELLBASED External Advisory Board member, you will:

- Contribute to the project communication and dissemination activities.

Selection criteria

Candidates are expected to have:

- Experience related to one or more of the following topics:
 - energy policy
 - urban policy & development
 - poverty & energy poverty
 - energy efficiency
 - evidence-based policies/approaches
 - o implementation of interventions to reduce energy poverty in practice
 - social care and vulnerable groups
 - o inequality & social inclusion
 - health care, urban health & health inequalities
 - o socioecological model
 - o methodology, data management and ethics
 - o business models and financial schemes for energy poverty intervention
- Adequate command of English and tools for on-line communication
- Be EU/EEA/EFTA/Accessing/candidate countries nationals or have their place of residence or work in this area.
- Availability to participate in the tasks of the External Advisory Board (estimated to be 6 days of work), including:
 - expert advice/consultation on (depending on the expert's background):
 - The definition of the WELLBASED urban plan framework
 - The project's evaluation framework
 - Exploitation, business & financing models
 - Policy recommendations for the scaling up & transferability of evidence-based urban policies to reduce energy poverty
 - The research protocols
 - The Ethics Management Plan
 - The Data Management Plan
 - The implementation of Al-ethics in Al-based tools used and developed

Terms and conditions

Eligible costs:

 Working time for involvement in the tasks described in "Expectations": Flat rate of 2.700,00€ per expert.

Payment will be done within 40 days after the submission of an activity report.

 Travel expenses for face-to-face meetings: Reimbursement of expenses covering: transport, accommodation and meals prior submission of receipts and up to a maximum amount of 1.000,00 €/trip

Travels must be organized based on the most appropriate means of transport and trying to benefit from the most economical travel rates.

It is foreseen the attendance to 2 meetings.

Payment will be done within 40 days after the submission of the expenses settlement document of each trip.

Selection process

The selection committee will review the applications review considering the following criteria:

- 3. Ability to evaluate complex issues and weigh conflicting opinions in order to develop policy recommendations.





- 4. Expertise related to the tasks as detailed above.
- 5. Diversity of the members of the Advisory Board as a whole regarding background/expertise.

Gender and geographical balance will also be considered among the selection criteria. Upon completion of the selection, candidates will be informed about the results no later than one monthafter the application deadline.
